ASSAULT	9500 Cane Creek - The complainant got into an altercation with a suspect at the light at Louetta and Cutten Road. The suspect followed the complainant home and assaulted him. The complainant received minor injuries and the suspect was arrested. Case close
BURGLARY / HABITATION/BUS	16300 Luzerne Drive -The complainant discovered that her home had been burglarized. The suspect took personal items. This case is open and under investigation.
CRIMINAL MISCHIEF	10000 Cane Creek - The complainant left her vehicle parked on the driveway overnight and the next morning the back window was shattered. There are no witnesses or suspects at this time. Case pending information.
CRIMINAL MISCHIEF	16200 Cutten Road - The complainant reported there was forced entry to his residence. No evidence of forced entry was found. Case inactive.
DISTURBANCE / FAMILY	16000 Sweet Fern - The suspect and the complainant got into an argument. The two pushed each other, but both parties stated it was an argument that got out of hand. Case closed referred to JP court.
DISTURBANCE / FAMILY	16000 Timber Valley -. The suspect pushed the complainant. The complainant did not want to file charges and was referred to JP court for class C violation. Case Closed.
OTHER CALLS	10100 Carter Road - Deputy Drake stopped a vehicle with expired registration and the driver had no driver license and no insurance. The vehicle was towed and the driver and passengers were released. Case closed.
