ASSAULT	08-38457 - 16300 Luzerene Drive - Complainant was asked to come outside in the early morning hours to smoke with a friend who assaulted him with a bat. Complainant went to the hospital the next morning & the police were called. Charges filed. Closed.
ASSAULT	08-39469 - 16200 Emberwood Drive - Complainant tried to stop her son from leaving the residence. The son pushed the mother to the ground and drove off. The mother claimed minor injuries and the DA's office refused charges. Case closed.
ASSAULT	08-42158 - 16300 Bohnhof Strasse - The neighbors got into an argument over an accident that occurred several days ago. The fight turned physical and one neighbor grabbed a knife and stabbed the other. Charges filed on the suspect. Case closed.
ASSAULT	08-45208 - 9300 Cedar Point Circle - Complainant reported being slapped by his girlfriend while sitting at his desk playing a game. The girlfriend slapped him because he was calling her names. No charges filed by both parties. Case closed.
